STIPULATION WITHDRAWING MOTION OF IVAN HOLLE FOR ENTRY OF AN ORDER GRANTING: (1) LEAVE TO FILE A LATE FILED CLAIM, (2) RELIEF FROM THE PLAN INJUNCTION, AND (3) ABSTENTION UNDER 28 U.S.C. § 1334(C)

This stipulation (the “Stipulation”) is entered into by and between Ivan Holle (“Holle”), J.H. Cohn LLP (the “Creditor Agent”), in its capacity as Unsecured Creditor Agent in the above-captioned chapter 11 cases, and the above-captioned debtors and debtors-in-possession, as reorganized (collectively, the “Reorganized Debtors”), by and through their undersigned attorneys, (together, the “Parties”). The Parties hereby stipulate and agree as follows:

1. On November 2, 2011, Holle filed the *Motion of Ivan Holle for Entry of an Order Granting: (1) Leave to File a Late Filed Claim, (2) Relief From the Plan Injunction, and (3) Abstention under 28 U.S.C. § 1334(c)* [Docket No. 3593] (the “Motion”).

2. On November 22, 2011, the Creditor Agent filed the *Unsecured Creditor Agent’s Objection to Motion of Ivan Holle for Entry of an Order Granting: (1) Leave to File a Late Claim, (2) Relief From the Plan Injunction, and (3) Abstention Under 28 U.S.C. § 1334(c)* [Docket No. 3606].

3. On November 22, 2011, the Reorganized Debtors filed the *Reorganized Debtors’ Limited Objection to Motion of Ivan Holle for Entry of an Order Granting: (1) Leave to File a Late-Filed Claim, (2) Relief From the Plan Injunction, and (3) Abstention Under 28 U.S.C. § 1334(c)* [Docket No. 3707].

4. The Parties hereby stipulate to the withdrawal of the Motion without prejudice.
